Product Overview

The Beef Cattle Nutrient Requirements Model (BCNRM) is an analytical nutrition modeling tool used for educational, research, and decision-support purposes in beef cattle nutrition. The software is implemented as a Microsoft Excel workbook and operates entirely within the Microsoft Excel application environment. BCNRM does not include a custom user interface, standalone executable, web application, or proprietary graphical framework.

Accessibility Approach

BCNRM relies exclusively on Microsoft Excel for all user interaction, navigation, data entry, visualization, and output presentation. As such, accessibility support for BCNRM is provided through Microsoft Excel's built-in accessibility features and its integration with the underlying Windows operating system and assistive technologies.

No custom controls, widgets, input methods, or interaction mechanisms outside of standard Excel functionality are implemented within BCNRM. The product does not introduce accessibility barriers beyond those inherent to the Excel platform itself.

Applicable Accessibility Standards

An Accessibility Conformance Report (ACR) has been completed for BCNRM using the **VPAT® Version 2.5Rev (International Edition)**. The ACR documents conformance with the following standards, as applicable:

- **WCAG 2.0 Level A and Level AA**, as incorporated into the Revised Section 508 standards
- **Revised Section 508 of the U.S. Rehabilitation Act (2017)**

Criteria related exclusively to web content, multimedia, hardware, telecommunications, or closed-functionality software were determined to be **Not Applicable** due to the nature of the product.

Evaluation Methodology

Accessibility evaluation was conducted by reviewing BCNRM's dependence on Microsoft Excel for all accessibility-relevant functionality and by referencing Microsoft's publicly available Accessibility Conformance Reports for Microsoft Excel and Microsoft Office. These reports document Excel's support for keyboard navigation, screen reader compatibility, text resizing, contrast controls, focus management, and interoperability with assistive technologies.

Scope Clarification

This Accessibility Conformance Report and summary apply **only** to the Excel-based BCNRM product distributed via NutritionModels.com. Other compiled desktop applications available on the NutritionModels.com website use different technical architectures and are outside the scope of this report. Accessibility for those products is evaluated separately if required.

Conclusion

Based on its reliance on Microsoft Excel and the documented accessibility support provided by that platform, BCNRM is considered accessible in accordance with applicable WCAG 2.0 Level A and AA success criteria and Revised Section 508 requirements, within the context of an Excel-based desktop application.
