Product Overview

The software products covered by this Accessibility Conformance Report (ACR) are compiled Windows desktop applications developed and distributed via NutritionModels.com. These applications support scientific modeling, data analytics, utilities, and educational activities, primarily in the areas of ruminant nutrition and related computational analyses. All products covered by this report are implemented using Visual Basic .NET or Visual Basic 6 with WinForms user interfaces and are intended for use on Microsoft Windows operating systems.

Accessibility Approach

The applications rely on **standard Windows and WinForms controls** for all user interaction, navigation, data entry, and output presentation. Keyboard and mouse input are supported, and standard tab-order focus behavior is provided by the Windows operating system and WinForms framework. Accessibility support for these applications is therefore derived from the underlying Windows accessibility services and standard control implementations, including compatibility with assistive technologies that rely on Windows UI Automation and related accessibility APIs. The software does not implement custom-drawn controls or proprietary interaction frameworks that would bypass standard platform accessibility mechanisms.

Graphics, Charts, and Non-Text Content

Some applications include charts, plots, or graphical visualizations. These graphical elements are **informational only** and are not the sole means of conveying results. Numeric, tabular, or textual alternatives are always available through reports, data tables, or exported outputs. Formal screen reader testing of graphical elements has not been conducted; therefore, accessibility for non-text content is documented conservatively in the ACR.

Applicable Accessibility Standards

An Accessibility Conformance Report has been completed for these applications using the **VPAT® Version 2.5Rev (International Edition)**. The report documents conformance with the following standards, as applicable:

- **WCAG 2.0 Level A and Level AA**, as incorporated into the Revised Section 508 standards
- **Revised Section 508 of the U.S. Rehabilitation Act (2017)**

Criteria related exclusively to web content, multimedia, telecommunications, hardware, or closed-functionality software were determined to be **Not Applicable** based on the desktop nature of the applications.

Evaluation Methodology

Accessibility evaluation was conducted through architectural and functional review of the applications' use of WinForms controls, keyboard operability, input handling, and output mechanisms. The evaluation reflects a **conservative and honest posture**, acknowledging reliance on platform accessibility features and the absence of formal third-party or screen reader testing.

Scope Clarification

This summary and the accompanying ACR apply **only** to compiled Windows desktop applications distributed via NutritionModels.com.

Excel-based products, including the Beef Cattle Nutrient Requirements Model (BCNRM), are explicitly excluded from this report and are documented under a separate Accessibility Conformance Report.

Based on their implementation using standard WinForms controls and reliance on Windows accessibility services, the compiled desktop applications distributed via NutritionModels.com provide keyboard accessibility and compatibility with assistive technologies consistent with applicable WCAG 2.0 Level A and AA criteria and Revised Section 508 requirements, within the context of scientific and analytical Windows desktop software.

Evaluation Methods Used: Accessibility evaluation was conducted through a review of the software architecture, user interface framework, and interaction patterns common across the covered applications. The evaluation focused on the use of standard Windows and WinForms controls, keyboard accessibility, reliance on Windows accessibility services, and availability of non-visual alternatives for graphical outputs. No formal third-party or screen reader testing has been conducted. Accessibility support is based on the

applications' reliance on standard Windows controls and operating system accessibility APIs.
